On October 15, 2020, the Department of Justice (DOJ) grant making components – [the Office of Community Oriented Policing Services \(COPS Office\)](#), [the Office of Justice Programs \(OJP\)](#), and [the Office on Violence Against Women \(OVW\)](#)- transitioned to one grants management system (JustGrants) for all three grant making components and a new payment management system (ASAP).
