On October 15, 2020, the Department of Justice (DOJ) grant making components — the Office of Community Oriented Policing Services (COPS Office), the Office of Justice Programs (OJP), and the Office on Violence Against Women (OVW) — transitioned to one grants management system (JustGrants) for all three grant making components and a new payment management system (ASAP).

Award recipients can resume drawdown requests at that time and can request and receive payments during the JustGrants system outage.
