JUSTICE GRANTS SYSTEM

Today, the Department of Justice grant making components—the [Office of Community Oriented Policing Services \(COPS Office\)](#), the [Office of Justice Programs \(OJP\)](#), and the [Office on Violence Against Women \(OVW\)](#)— transitioned to one grants management system (JustGrants) for all three grant components and a new payment management system (ASAP).

JustGrants Now Available

Starting today, October 15, 2020, the Justice Grants System (JustGrants) supports all functionalities necessary to support the essential stages of the grant management lifecycle.

Upon logging in to JustGrants, you will arrive on the landing page. Once you find and associate your respective awards and tasks with your profile, your landing page will be updated so you can easily view and take action on your work.

We recommend you use Microsoft Edge or Google Chrome for the best possible user experience upon logging in to JustGrants.

Key Information

Where do I log in to JustGrants? You can access JustGrants by clicking [here](#) and bookmarking the link or by clicking the “Login” link on the [Justice Grants website](#).

How do I log in to JustGrants? What is my password? When logging in to JustGrants, you should use the credentials (i.e., user name and password) that you established during the secure entity onboarding process and/or when you were invited by your organization’s Entity Administrator to register in JustGrants.

- Is your organization not yet enrolled in JustGrants?
 - Current award recipients should have received invitations to register in JustGrants and ASAP. Refer to the [ASAP Registration Checklist](#) and the [JustGrants Entity and User Onboarding Checklist](#) to learn about the enrollment and onboarding process.
 - Applicants who are not current award recipients will receive information on how to enroll in JustGrants as part of the grant application process. Prospective grant applicants do not need to proactively register in JustGrants at this time.
- Are you not yet individually registered in JustGrants?
 - Please work with your organization’s Entity Administrator to secure an invitation to JustGrants. The Entity Administrator is also responsible for [assigning appropriate roles](#) to all users from your organization in JustGrants.
- Forgot your user name or password?
 - In JustGrants, you can reset your own password. To learn about self-service options, please refer to [this guide](#).

- If you have not received an email with instructions for entity onboarding to JustGrants or registering with ASAP, you can take the following steps:
 - Check your Electronic Business Point of Contact (E-Biz POC) designation in SAM and, if necessary, correct the E-Biz POC contact information.
 - Have your E-Biz POC check their SPAM folders for onboarding enrollment invitations from DIAMDNoReply@usdoj.gov. Please note, this email address is only used for email dissemination and the inbox is not monitored.
 - If the invitations are not found in SPAM folders, email JustGrants.Support@usdoj.gov to inquire about the status of your invitation emails.

Accepting Fiscal Year 2020 Awards in JustGrants

If you were notified of your fiscal year (FY) 2020 award from either the legacy Grants Management System (GMS) or NexGen system and you did not accept your awards in those systems prior to September 23, 2020, you will need to accept your award in JustGrants beginning October 15, 2020.

FY 2020 awards that were not made prior to September 23, 2020, will be made through JustGrants starting on October 15, 2020. You will complete the entire process of reviewing and accepting your award within JustGrants.

The process of accepting or declining an award does not require printing and signing a PDF to accept the award. Instead, it will now be done electronically by your Authorized Representative in JustGrants.

A few important points to note:

- Entities must successfully set up their JustGrants account and enroll in ASAP in order to accept and manage their award(s).

- Prior to accepting an award, the Entity Administrator must assign a finance manager and a grants administrator. Review the [JustGrants Roles](#) overview for more information.
- COPS Office grantees will have two Authorized Representatives, both of whom are required to accept the award.
- Each Authorized Representative, Application Submitter, and Entity Administrator will receive an email notification to accept their award.

When the Authorized Representative(s) logs into their JustGrants account, they will be able view all migrated active awards for their entity.

To accept an award in JustGrants, follow these instructions:

1. Sign in to [JustGrants](#).
2. Select an award from “My Worklist.”
3. To accept the award, you need to open and accept the information for each tab of the “Award Details” page.
4. Once you have selected all acceptance boxes in each tab, click “Accept” to proceed. After accepting, the system will display a banner indicating that the award has been accepted.
5. If you do not wish to accept the award, select the “Decline” button to proceed.

Drawdowns in the Automated Standard Application for Payments (ASAP)

Your organization’s E-Biz POC should have received an ASAP enrollment email invitation and completed the ASAP enrollment. If you have not received your ASAP enrollment email invitation or need assistance in completing the ASAP enrollment, contact Ask.OCFO@usdoj.gov. Please be sure to provide your organization’s DUNS when contacting Ask.OCFO@usdoj.gov.

A few ASAP enrollment reminders:

- You have 45 days to complete ASAP enrollment.
- Once enrollment steps are complete, there is a 5-business-day bank account verification period. Access to accounts and funding will not be available until the verification process is complete.
